## THREE-WAY STUDENT AID PLAN

The Southern New England Conference has made provision to grant student aid funds to worthy students attending SNEC Elementary Schools, Greater Boston Academy, South Lancaster Academy, or other SDA Conference Operated Boarding Academies who might otherwise be deprived of a Christian education.

These scholarship funds are paid twice each school year, during the months of November and April. Upon receiving these funds, the participating elementary school, or academy will credit its portion of student aid to the student's account.

It is understood that parents and relatives ARE NOT permitted to make a specific contribution to the local church student aid fund for their son, daughter, or relative, with the thought in mind of having it sent on to the Conference and school for matching funds.
